

COMMUTER TRAIN DELAYS

NOVEMBER 2017 TO FEBRUARY 2018

CLASS ACTION SETTLEMENT

A **class action** was authorized on April 1, 2020, and amended on May 5, 2020, against the Réseau de transport métropolitain (“**exo**”) and the Autorité régionale de transport métropolitain (“**ARTM**”) on behalf of the group described below:

*“All persons who paid for an **exo** transit fare to travel on the Deux-Montagnes or Mascouche train lines at any time between November 1, 2017, and February 28, 2018.” (the “**Members**”)*

A settlement agreement has been reached between the parties for the payment of a maximum amount to eligible Members as outlined in the tables below, as well as an amount to the Members’ lawyers as compensation for their fees, drawn from the settlement fund, all without any admission of liability (the “**Settlement Agreement**”). This agreement may affect your rights.

An amount of \$75,000.00 will also be paid to Trajectoire Québec as indirect compensation for Members who purchased one or more 1-trip tickets.

An approval hearing on the Settlement Agreement will be held before the Honourable Céline Legendre, J.S.C., on **August 14, 2025, at 9:30 a.m. in room 15.08** of the Montreal Courthouse (1 Notre-Dame Street East, Montreal, Quebec H2Y 1B6).

If you disagree with the Settlement Agreement or with the proposed distribution of the balance, you may inform the Court of your objection at the hearing.

A new notice will be published at the time of the final judgment on the approval of the settlement.
